



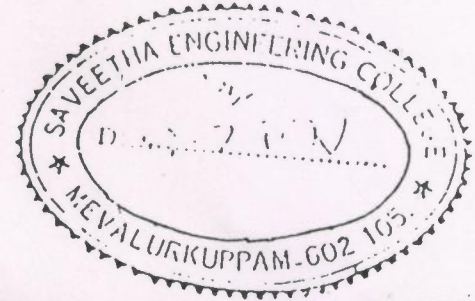

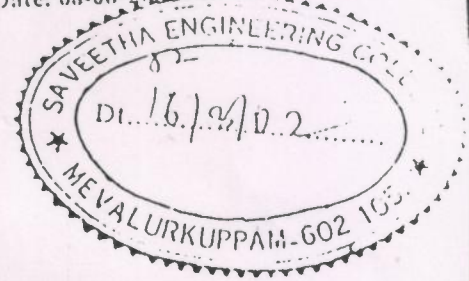

Based on the report of expert committee revisit and subsequent recommendations of Regional Committee, the All India Council for Technical Education (AICTE), is pleased to accord approval for the following additional course/increase in intake with the specific conditions as stated below:-

1. The conditions imposed by the concerned university regarding its criteria for affiliation, admission and academic schedule are fulfilled as per the university rules.
2. That the State Government is in a position to provide students through central counseling as per its schedule for the current academic session, if not so the approval may be revalidated as per rules by the Council for the academic year 2003-04.
